

## Float Your Boat – People's Choice Award

### Terms and Conditions 2025

1. Information on how to enter and prizes form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of the Terms and Conditions and any entry not complying with these Terms and Conditions is invalid.
2. Entry is open to Australian residents over the age of 16. Any entrant under the age of 18 years must have their parent or guardian's permission to enter the promotion. Employees of the Promoter and their immediate families are ineligible to enter.
3. The Promotion commences at 5:00pm Australian Eastern Standard Time ("AEST") on Friday 20 June 2025 (once competition is live online – [lakemac.com.au/fybvote](http://lakemac.com.au/fybvote)) and close at 11:59pm AEST on Sunday 29 June 2025 ("Promotion Period").
4. To enter, entrants must:
  - 1) Complete the online voting form – [lakemac.com.au/fybvote](http://lakemac.com.au/fybvote)
  - 2) Select their favourite boat
  - 3) Enter full name, email address and mobile phone number
5. Only one (1) entry is permitted per entrant.
6. There is one major prize: a VISA Giftcard valued at \$100 recommended retail price ("RRP").
7. Total prize pool for the public voting on the People's Choice Award promotion is valued at \$100 RRP.
8. Total prize pool for the boaties involved in the Float Your Boat flotilla is \$2000 divided into first place \$1000, second place \$600 and third place \$400.
  - a. In the case of a tie for first place, the prize money (total of \$1000) will be split between the two (2) winners so \$500 each.

9. The People's Choice Award votes will be counted and the winning boats and creators announced on Monday 30 June 2025 by 5pm.
10. The winner of the VISA Giftcard will be notified by telephone or email by 3pm, Tuesday 1 July 2025.
11. The Promoter reserves the right to verify the validity of all entries and reserves the right to disqualify any individual entrant or group of entrants for tampering with the entry process. The Promoter may in its complete discretion preclude the disqualified entrant from participation in any or all future promotions of the Promoter.

13. The prize value is correct at time of printing but no responsibility is accepted for any variation in the value of any prize.
