# TERMS AND CONDITIONS

Service option must be selected and if required balanced paid prior to event

## Pay on consumption:

- Beverages are purchased individually by guests, using EFTPOS only
- Pay on consumption bars are cashless with payment accepted via VISA, Mastercard or EFTPOS

## Tabbed service:

- Agreed tabbed amounts over \$3000 require a 50% deposit prior to event commencement. If there are unused funds from the 50% deposit it will be refunded after event.
- Tabbed beverage service is payable by card payment at conclusion of event, or invoice issue. Invoices are issued on net 14-day terms.

## Beverage service:

- Beverage packages are available for functions of 50 guests or more.
- Beverage packages are to be confirmed and paid in advance of event
- Prices are charged on guests over/under the age of 18 years old regardless of if consuming alcohol or not
- Guests under the age of 18 are charged at a reduced rate

## ALCOHOL SERVICE

- We are committed to delivering you a safe and successful event.
- Alcohol service will cease 30 minutes prior to the conclusion of your event when all patrons must vacate the premises.
- Beverage service option must be selected prior to the event.
- If deemed necessary for the safety of guests, drinks will be served in polycarbonate stemless glasses.
- During events wine is served to guests by the glass only.
- Every effort will be made to supply the beverage options selected. In the event a product is not available, we will consult with the hirer to replace it with another option of comparable quality.

## ALCOHOL POLICY

- We take our Responsible Service of Alcohol (RSA) obligations seriously and will enforce harm minimisation strategies to manage your event safely and reduce any risk or harm to guests, staff, and the community.
- All Lake Macquarie City Council function service staff are RSA trained.
- Hirers, suppliers, and guests cannot bring external alcohol into the venue.
- No self-service or BYO alcohol is permitted.
- Alcohol is not permitted to leave the licensed area of the venue at any time during the event.
- Alcohol will only be served to people over the age of eighteen (18), in accordance to liquor licensing laws concerning the supply of alcohol.
- Alcohol must be consumed alongside a substantial amount of food.
- No shots permitted.
- Alcohol must only be served and consumed in the designated licensed function areas including the art museum building, entry deck, balcony, terrace and marquee. In the event of the marquee not being onsite the grassed area 9 x 12m is included in the licensed area. All other areas are not approved and against our liquor license conditions.

## LAKE MACQUARIE CITY COUNCIL reserves the right to:

- Ask for acceptable forms of identification as proof of age.
- Not serve alcohol to minors (persons under 18 years of age).
- Stop serving alcohol if guests show signs of intoxication and ask the guest to leave the premises.
- Restrict the number of beverages served to guests.
- Adhere to the trading hours listed on our liquor license.
- Limit bar service at any time in accordance with our RSA policy
